

EXPRESSION OF INTEREST AND PREQUALIFICATION FOR BAMB ERP SOLUTION

BAMB seeks the submission of an Expression of Interest (EOI) from domestic and international Information Communication and Technology providers of an Enterprise Resource Planning (ERP) solutions. The solutions is intended to modernise and transform BAMB operations and services as an anchor for Tsosoloso 2024 (BAMB Strategy).

Through Tsosoloso 2024 (BAMB strategy) BAMB intents to be a one-stop-shop of choice for agricultural products and services by 2024. We will achieve this goal through our strategic programmes and our operational targets, and key to this is to ensure operational efficiency and achievement of the entire strategic intent through converged, modernised and seamless systems. These strategic programmes overarch Business Diversification, Efficiency Optimisation, Relationship Development and Intelligence Effectiveness. Critical to the achievement of the Tsosoloso is to tier together all strategic programmes and business processes to enable seamless flow of information to aid operational agility and decision making through the implementation of an Enterprise Resource Planning (ERP) solution project as well as post implementation support.

IN ORDER TO PREQUALIFY AND BE INVITED TO TENDER FOR THIS PROJECT, BIDDERS MUST FULFIL THE FOLLOWING CRITERIA:

- Provide a brief Company Profile including a brief history of the firm, shareholding and directorships, a summary of types of service offered, office resources, quality control procedures, amount of Professional Indemnity Insurance (not less than P1Million Cover) and Curriculum Vitae of key senior staff likely to be employed on this project, as well as for post implementation support;
- Provide certified proof of registration with the PPADB(Code 120 Sub code 01 and 2, Code 319 Sub code 01-04 and Code 311 Sub code 01) for domicile companies or similar procurement regulatory body as well as JV/Partnership agreement where applicable;
- 3. Provide VAT Registration Certificate or exemption;
- 4. Proof of Tax Clearance with the Botswana Unified Revenue Service or any other relevant tax authority;
- 5. Bidders must have demonstratable track record in the provision of ERP solution delivery business for the past five years as well a successful migration of critical business systems and data;
 - 5.1 Bidders must provide;
 - 5.1.1 Atleast three (3) references from a recent completed implementation from which one of these referees should be from an Agric retail establishment.
 - 5.1.2 A brief summary of projects completed, listing: project and client names, role in the project, project value and organisation size.
 - 5.1.3 A summary of any expertise they may have with respect to provisioning modernised ERP solutions.
- 6. Bidders are informed that at this juncture, the briefness of the submission is important. Submissions exceeding twenty (20) pages will be marked down in the evaluation.
